

Zedi Roughneck – May 28th Release Notes

The following enhancements and bug fixes were included in the release on Thursday May 28th, 2020.

Enhancements:

1. Additional equipment fields for PSVs and tanks

The following new equipment data fields were added for PSVs:

- a. PSV Service Company
- b. Back Pressure

For Tanks the new equipment fields are:

- a. Last In-Service Date
- b. Dip Check information for both current and previous measurements
 - i. Dates
 - ii. Depth measurement
 - iii. Substance
- c. Inspection Type
- d. Inspection Company

These new fields are all reportable and exportable to Excel within Roughneck.

2. Improved reporting on inspection dates and intervals

Reporting on inspections dates (ie VI inspection, VE Inspection, Ultrasonic surveys, etc) have all been consolidated into 1 reportable field per inspection type. Rather than multiple reportable fields for last, next date and interval you will now just see one reportable field for each and when reported on you will get all three included in your search results. We've also grouped them into a category called "inspections dates".

3. The HSE module has been assigned new default reportable fields when searching

More information will be provided at a glance when searching for incidents with this default. The new default fields are:

- Incident Status
- Incident ID
- Primary Incident Type
- Date Occurred
- Incident Involved
- Functional Group
- Area
- Downhole Location
- Surface location
- Explain the Incident
- Immediate Actions Taken
- Suggest Actions to be Taken

4. Additional Reportable Fields in the Location Module

In the last update we update for most companies, the Licensed Operator and Well/Facility Operator were added as reportable fields when using the advanced search and export to Excel features. This has now been added for all other companies.

Defects:

1. Fixed an issue on pipeline WO where the pipeline info (segment and location) were not being displayed
2. Addressed an issue with WO default reportable fields could not be modified for certain companies.
3. Several other minor bug fixes.
